Cataract Procedures

PER EYE

CATARACT SURGERY

Single-focus IOL—including pre-op, surgery, and post-op care (if not provided by referring doctor) . . . approx. \$4000

• Additional Fees for Premium IOLs and Services:

Toric single-focus IOL	\$1100
Extended-range-of-focus IOL or multifocal IOL*	\$1800
Toric extended-range-of-focus IOL*	\$2200

*Includes enhancements performed within 6 months.

• Extra Pre and Post-Op Care for Premium IOLs (if not provided by referring doctor):

Toric single-focus IOL	\$200
Extended-range-of-focus IOL or multifocal IOL	\$200
Toric extended-range-of-focus IOL	\$200

These fees are in addition to standard pre-op and 90-day post-op care.

Refractive Procedures

PER EYE

We encourage individual practitioners to establish fees and charge for the pre and post-op care they provide.

LASER VISION CORRECTION (LVC)

Wavefront optimized LASIK or PRK	\$1500
LASIK or PRK combined with any other procedure (performed within 6 months)	\$1100
Femtosecond laser flap option for LASIK (not available at all PCLI locations)	\$300

Includes enhancements if needed.

REFRACTIVE LENS EXCHANGE (RLE)

Single-focus IOL	\$3300
Toric single-focus IOL	\$4400
Extended-range-of-focus IOL or multifocal IOL	\$5100
Toric extended-range-of-focus IOL	\$5500

Includes enhancements and YAG laser capsulotomy if needed within 6 months.

READING VISION CORRECTION WITH KAMRA INLAY (available in our Bellevue, WA location)

Corneal inlay surgery (only one eye is treated)	\$3750
Pre and post-op care (if not provided by referring doctor)	\$850
